## OUR RECOMMENDATION: ACCEPT THE €45 WARBURG PINCUS OFFER

Q3/25 order intake, sales and adjusted EBIT were all above our forecasts. This was mainly because of better sales and EBIT than we had expected at the Grid & Energy Management segment and higher profitability than we had modelled at the Process Industries & Metals segment. Management continues to guide towards an increase in group new orders and revenues of 10% for the full year and an adjusted EBIT margin of 4%. Warburg Pincus, shareholders acting with Warburg Pincus, and E.ON now have a 53.4% stake in PSI. The minimum acceptance threshold for the €45 per share Warburg Pincus takeover (50% plus one share) has thus been exceeded and the offer can now proceed. The transaction is expected to close in H1 next year subject to approvals from the competition authorities in the countries in which PSI is active. Warburg Pincus intends to make a delisting offer following completion of the transaction. For a delisting offer, the minimum consideration must be at least the higher of two prices: the six-month volume-weighted average price (VWAP) prior to the offer's announcement, or the highest price paid by the bidder in the six months prior to the offer document's publication. Warburg Pincus also intends to make a compulsory squeeze-out if it acquires the necessary 95% of PSI. A squeeze-out will take place against the background of reduced liquidity and transparency (the listing will no longer be Prime Standard). We think the probability of a significant premium to the current offer is low - especially if a squeeze-out offer is made within a few months of the delisting offer. In our view shareholders would be well advised to accept the €45 per share Warburg Pincus offer which represents premia to undisturbed 3-month and 6-month VWAP prior to the bid of 63% and 57% respectively.

Q3/25 order intake jumped 34.1% The Q3/25 order intake was up 34.1% y-o-y at €59m (Fbe: €50m; Q3/24: €44m). Management tell us that the Grid & Energy Management segment saw the strongest growth, while the Discrete Manufacturing and Logistics segments also saw substantial increases.

Double digit sales growth at all segments besides Process Industries & Metals in Q3... As figure 2 overleaf shows, all PSI segments with the exception of Process Industries & Metals saw sales increases of at least 9% in Q3/25. The most important part of the Process Industries & Metals segment is the metals software business. Sales growth in this business is suffering from sluggish economic development in Europe and the imposition of tariffs on steel by President Trump.

...but Process Industries & Metals was the group's most profitable segment in Q3 Nevertheless, Process Industries & Metals was clearly PSI's most profitable segment in Q3/25 as its adjusted EBIT margin returned to double digits. The adjusted EBIT margins at the Discrete Manufacturing and Logistics segments were depressed by further investments in their transition towards a cloud and SaaS-based business model.

Exceptional €12m charge at Grid & Energy Management in Q3 In its Q2/25 report PSI announced that an efficiency and cost-cutting programme at the Grid & Energy Management segment would necessitate a high single digit charge in Q3/25. Following further discussions with the employee council (Betriebsrat), PSI increased the scope of this programme and took a charge of €12m against the Q3 P&L. The balance of the €24.7m restructuring/M&A charge taken in Q3/25 relates to the cost of the takeover transaction. This will be fully funded by Warburg Pincus.

Q3/25 net gearing rose to 132% (Q3/24: 82%) due to new lease on company HQ The pretax result in Q3/25 was €-22.9m (Q3/24: €-0.4m) as a consequence of the exceptional charges discussed above. However, the cash outflow from operations narrowed to €5.0m (Q3/23: €16.6m) due to the partial reversal of the exceptional charges in current liabilities. Q3/24 cashflow was burdened by an €11.1m reduction in current liabilities.

Nevertheless, net debt including pension and leasing liabilities jumped by €44.3m to €93.3m in Q3/25, equivalent to net gearing of 132% (Q3/24: net debt including pension and leasing liabilities of €72m, equivalent to net gearing of 82%) in connection with a new lease deal on the company's HQ in Berlin's Dircksenstrasse.

We recommend that investors accept the €45 per share Warburg Pincus offer We have adjusted our forecasts (see figure 3 overleaf) to reflect the Q3/25 results. 2025E EPS is lower because of the impact of the higher than previously modelled restructuring charge at Grid & Energy Management and the takeover bid transaction costs. The main change to our 2026 forecast is an upward revision to Grid & Energy Management 2026 adjusted EBIT in the expectation that the more extensive than previously expected restructuring measures at the segment accelerate margin improvement. We recommend that investors accept the €45 per share Warburg Pincus offer for the reasons outlined above. The price target in our most recent note, published in August following the Q2/25 results, was €40.

The present financial analysis is based on the author's own knowledge and research. Our recommendation system places each company into one of two market capitalisation categories. Category 1 companies have a market capitalisation of  $\in 0 - \in 2$  billion, and Category 2 companies have a market capitalisation of  $> \in 2$  billion. The expected return thresholds underlying our recommendation system are lower for Category 2 companies than for Category 1 companies. This reflects the generally lower level of risk associated with higher market capitalisation companies.

### RISK ASSESSMENT

The First Berlin categories for risk assessment are low, average, high and speculative. They are determined by ten factors: Corporate governance, quality of earnings, management strength, balance sheet and financial risk, competitive position, standard of financial disclosure, regulatory and political uncertainty, strength of brandname, market capitalisation and free float. These risk factors are incorporated into the First Berlin valuation models and are thus included in the target prices. First Berlin customers may request the models.
